

# **Godfrey Payton Lettings fee Guide (Residential)**

w.e.f: 1st February 2024

Letting Agents are obliged to display their fees publicly. Godfrey Payton, as Letting Agents, offer different levels of service to our Landlords depending on their needs. The fee schedules below outline the level of fees payable depending on the chosen level of service; Tenant Find only, Rent Collection only and Full Management.

The fees are split into two categories;

- The Landlord letting fee for finding and arranging a new tenancy agreement.
- The Management fee for ongoing rent collection and management of the Landlord and Tenant relationship (not applicable for Tenant Find only).

Additional fees may be necessary for additional services and these are displayed under 'additional ad hoc services fees.' Where further clarity is required on our fees please speak directly to our Letting Agents.

Fees are displayed <u>including VAT.</u> Fee invoices will detail the net fee to Godfrey Payton and the amount of VAT payable.
